Terms And Conditions of the Auction Tender

SEALED BIDS are invited by MP Rural Road Development Authority, Block-2, 5th Floor, Paryawas Bhawan, Arera Hills, Bhopal (MP) for the disposal of one Scorpio vehicle mentioned hereunder on “as is where is” basis.

The Bidder should clearly specify the rate in the Auction Tender Form available at official web site www.mprrda.com which should be submitted on or before 03.00 p.m. on, the date 14/06/16 in a Sealed Envelope. The sealed Auction Bids will be opened at 03.30 p.m. on the same day in the presence of the Bidders or their authorized representatives at Block-2, 5th Floor, Paryawas Bhawan, Arera Hills, Bhopal (MP).
2. The bids should be sent in a **sealed Envelope in prescribed form** addressed to

superscribing the envelope as ‘**Tender for disposal of Vehicles**’
3. The bidder should submit an E.M.D. for an amount of **Rs. 3500/-** only in the form of Demand Draft/Bankers’ Cheque drawn in favour of “**CEO, MP Rural Road Development Authority**”. payable at **Bhopal** in a separate envelope alongwith the Auction Tender bid in a sealed envelope. No payment by Cheque will be accepted. Contents of each envelope and name of bidder should be clearly mentioned on each envelope.

4. Tenders without E.M.D. will not be entertained and returned unopened. First envelope containing EMD will be opened. Financial bid shall be opened only when EMD found in order.
5. The EMD receive from the unsuccessful bidder will be returned after finalization of the Auction Bids.
6. Applicable VAT and other taxes, if any, will be charged extra as per rules inforce at the time of issue of the Sale Confirmation Order.

7. The successful bidder should pay the **sale value within seven days** repeat *seven days* From the date of issue of the sale confirmation order (excluding the date of issue) failing which the EMD remitted by the Bidder will be forfeited without further notice.
8. The payment should be made by demand draft drawn on any scheduled bank drawn in favour of “CEO, MP Rural Road Development Authority”, payable at Bhopal. Payment made by Cheque will not be accepted on any account.
9. The successful bidder should remove the vehicles connected with this Auction tender within 15 days from the date of issue of the Sale Confirmation Order.
10. The successful bidder should take delivery of the vehicles at his own risk and expenses, within 15 days from the date of issue of the Sale confirmation order failing which a ground rent at the rate of Rs. 500/- per week will be charged extra from the successful bidder.
11. The bidder may, before submission of the bid, inspect the vehicle at any time during office-working hours (10.30 A.M. to 5.30 P.M.) upto 13/06/16. No claim about quality, quantity, description and the value of vehicle sold will be entertained under any circumstances after the bids are finalized and no complaints will be entertained on this matter.
12. MPRRDA will not take any responsibility for the safety of the vehicle after issue of the Sale Confirmation Order beyond the stipulated time and payment of the consideration.
13. The Bidder shall employ such means of arrangement for the removal of vehicle and make proper means of transport as they will not damage the roads/buildings in the office premises. Any damage caused to the roads/buildings during such removal should be made good by the Bidder at his own expense.
14. The Chief Executive Officer, MPRRDA reserves the right to reject all or any of the Bids, at his discretion, without assigning any reason whatsoever and the decision of the CEO in this regard will be final and binding on all the Bidders.
15. If the bid is submitted by a firm, it should be signed in all the partners or by a partner who is authorized to do so by the firm. Document in support of such authorization should be attached. if the Bid is made by an individual, it shall be signed with his full name and furnish his present postal address.
16. Any correction in the AUCTION TENDER form should invariably be authenticated by the bidder, failing which the bid will be liable for rejection.
17. On complete fulfillment of the sale by the successful bidder to the satisfaction of the MPRRDA, the Earnest Money Deposit shall be returned within fifteen days after deducting the amount, if any due from the bidder to the MPRRDA.
18. The rates quoted by the bidder should be in Rupees. Any other levy or duty will be the liability of the successful bidder only.
19. The successful bidder is responsible for all acts done either by him, by his servants or representatives for the clearance/removal of the vehicles bid by him.

20. In case of disputes, it should be clearly understood that the decision of the CEO MPRRDA will be final and binding.
21. In case of disputes, this offer/comment is subject to the jurisdiction of the Courts in Bhopal only.
22. The Sale Confirmation Order once awarded is not transferable.
23. Any notice to the Successful Bidder shall be deemed to be sufficiently served if it is given in writing by post to his address as given by him in the Auction Tender Form.
24. Bidders will be deemed to have read and accepted all the terms and conditions afore mentioned.
25. Offer should be valid for a minimum period of 60 days. In the event of withdrawal of offer by bidder within validity period EMD shall stand forfeited and bidder will be debarred from participation in future tenders.
