EMPANELMENT OF STATE QUALITY MONITORS

Madhya Pradesh Rural Road Development Authority (MPRRDA) has been constituted by the Government of Madhya Pradesh for execution of Rural Roads under Pradhan Mantri Gram Sadak Yojna. For supervision and quality control of road construction, MPRRDA has engaged qualified and renowned consultants.

The Authority intends to empanel independent Quality Monitors for inspection of PMGSY roads and other works being executed by the Authority. The independent quality monitors will be required to visit the works as per programme given by the Authority and submit their report relating to the quality of works inspected. The Quality Monitors will be entitled to Travelling Allowance, which was admissible to them at the time of retirement and Honorarium as per MPRRDA rules.

Chief Engineers/ Superintending Engineers / Executive Engineers (or equivalent) having Educational Qualification of B.E.(civil) or equivalent retired or retiring upto March-2017 from Central/State Govt. deptt./undertaking, MPSEB and its companies, MES etc. having residence in M.P. who have adequate experience of construction of civil engineering works including roads, Highways and Bridges etc. and are interested to work as independent quality monitor and having good physical health to carry out inspection work may submit their willingness in the prescribed format (available on our website www.mprrda.com) addressed to the Chief Executive Officer, M. P. Rural Road Development Authority, Block -2, Vth Floor, paryawas Bhawan, Arera Hill's, Jail Road, Bhopal -462004, so as to reach not later than **16-01-2017**. Willing senior engineers may be required to undergo a short personal interview.

Empanelled SQMs are expected to proceed on tour for inspection in any part of the state as and when required.

- 1- Officers empanelled as NQM with NRRDA.**
- 2- Officers empanelled as SQM with any other state.**
- 3- Officers completing in 68 years of Age as on 31-12-2016.**
- 4- Officers who have were not selected in last SQM interview in MPRRDA held in Oct.-2016.**
